Conditions:

1. Shall obtain permission of the APNMC, Vijayawada every year.
2. The Physical facilities, clinical facilities, teaching and other staff should be as per the Norms of Indian Nursing Council, New Delhi and as per Dr.NTR UHS Statutes.

3. Dr.NTR UHS may conduct surprise inspections at any time for verification of college facilities.
4. In case if any of the information furnished by the Institution is false or misleading the University has a right to withdraw the permission without further notice.
5. Should upload the attendance of all admitted students "online" through Biometric devices compulsorily.
6. Should get mandatory registration of all the students admitted and undergoing Nursing Course, into Digital Library and NTRMEDNET Consortium and submit the list of candidates registered, to the University and Remote XS.
7. Should upload the data of admitted students to APSCHE and AISHE portals every year as per the time frame given by the APSCHE.

Further, the Principal of the institution is fully responsible to fulfill and maintain norms including the infrastructure both physical and human resource, teaching faculty and clinical facility etc, throughout the academic year, as stipulated in Regulation of INC, New Delhi/Statutes of Dr.NTR UHS, Vijayawada.

The Number of students admitted do not exceed the number of students permitted for annual admissions both under free and Management quota as specified by the Government of Andhra Pradesh / Dr.NTR UHS.

The fee collected by what so ever name called either for free seats or for Management seats do not exceed the limits specified by the Government of Andhra Pradesh / Dr.NTR UHS from time to time.

The Management of the college shall follow the regulations made by the Government of Andhra Pradesh / Dr.NTR University of Health Sciences / Indian Nursing Council in making admissions, in conducting examinations and in respect of all other related matters from time to time. Any violations in this regard may lead to disaffiliation of the college without any notice.
