In the letter dt.8-2-2013, the Principal, S.V.Medical College, Tirupati and Member Convenor, District Level Team, Chittoor District has submitted inspection report in respect of Sri Vikas College of Nursing, P.V.P. Nagar, Akkaram Palli Post, Mangalam Road, Tirupati, Chittoor District stating that the inspection team has stated that the clinical and teaching facilities, Laboratories are available as per Indian Nursing Council norms and recommended for Post basic B.Sc (Nursing) course with intake sixty (60)."

The Chairman, High Power Committee has requested the Government to issue No Objection /Essentiality Certificate in respect of Sri Vikas College of Nursing, Tirupati with an intake capacity of thirty (30) seats per year as per G.O.Ms.No.269, HM & FW (K2) Dept., dt.30-11-2009, since they have fulfilled the requirements of eligibility stipulated by NTR University of Health Sciences and INC guidelines.

The Government after careful examination of the matter has decided to accept the recommendation of the District Level Team/High Power Committee to start Post Basic B.Sc., (N) Course and accordingly hereby accord permission to start the Post Basic B.Sc., (Nursing) of 2 (two) years condensed course with an intake capacity of thirty (30) seats in Sri Vikas College of Nursing, No.6-2-86, M.H.Road, Tirupati with the condition that separate classes should be conducted for the Post Basic B.Sc. 2. After careful consideration of the matter, and in exercise of the powers conferred under sub rule (ii) of rule 15 of Andhra Pradesh Private Colleges of Nursing (Grant of Permission to Private Colleges or Institutions and Admissions into B.Sc. Nursing Course) Rules, 1997 made under section 99 of Andhra Pradesh Education Act, 1982 (Act 1 of 1982), Government hereby accord permission to the following educational society to establish the institution as mentioned below and to start degree course in B.Sc. Nursing of four years duration with an intake capacity of fifty (50) and clinical attachment specified below from the academic year 2005-2006, subject to obtaining affiliation to N.T.R University of Health Sciences, A.P., Vijayawada and Indian Nursing Council, New Delhi:-

- 3. The permission accorded in para (2) above is subject to the following conditions:-
- That the Institute should obtain affiliation duly fulfilling all the conditions stipulated as per the statutes of the N.T.R. University of Health Sciences, Vijayawada, Andhra Pradesh and payment of annual affiliation fee as may be prescribed from time to time to N.T.R. University of Health Sciences, Vijayawada and clearance from the Indian Nursing Council, New Delhi In case the aforesaid Educational Society fails to fulfill the conditions or fails to start the B.Sc. Nursing course within a period of one year, the permission now accorded will be cancelled.
- (2) The annual intake of students should not exceed as specified above to the Institute and the institute should fulfill and abide the rules and applied to the Institute.

- 4. The aforesaid Educational Society should also follow the following instructions scrupulously:
 - The Institute should run regularly with the required infrastructural facilities, (1) equipments, teaching staff, office rooms and clinical facilities, hostel facility, library books as per the statutes and regulations of N.T.R. University of Health Sciences, Vijayawada and as per the regulations of the Indian Nursing Council, New Delhi and should run in the best interests of students and it will be inspected by an inspecting officer appointed by Govt. or NTR University of Health Sciences or Indian Nursing Council, New Delhi
 - The students hostels, wherever provided are adequately furnished with appropriate (ii) areas for their comfortable stay and provision is made for their indoor/outdoor games.
 - The procedure prescribed by Government or N.T.R. U.H.S., for the selection, (iii) collection of fees, admission of students, rule of reservation, local, non-local areas and conducting examinations should be scrupulously followed.
 - The Institute should not have or open branches on the same place or elsewhere in the (iv) State or out side State.
- 5. The permission granted in para (2) above is liable for cancellation whenever the Government or NTR University of Health Sciences, Vijayawada or Indian Nursing Council, New Delhi forms the opinion based on an inspection report that the aforementioned Educational Societies are not running the college in the best interests of the students or commits any irregularity or violates any rule/regulation after giving 15 days notice to the Educational Society to show cause, against the proposed cancellation and pass appropriate orders after considering the explanation, if any, offered by the Society against the show cause notice.
- The Registrar, NTR University of Health Sciences, Vijayawada shall communicate the final decision of acceptance or rejection of affiliation and recognition to the aforementioned Educational Society, as the case may be within a period of three months from the date of issue of this order.
